

**Devon County Council (Various Roads, South Zeal) (No Waiting & Parking Restrictions)  
Amendment Order**

Devon County Council make the following order under sections 1, 2, 4, 32, 35 of the Road Traffic Regulation Act 1984 & of all other enabling powers

- 1 This order comes into force \_\_\_\_\_ and may be cited as “Devon County Council (Various Roads, South Zeal) (No Waiting & Parking Restrictions) Amendment Order \_\_\_\_\_”
- 2 The schedules are added to Devon County Council (Traffic Regulation & On-Street Parking Places) Consolidation Order 2017 as amended

**Schedule 1.001            No Waiting At Any Time**

**Road from Shilhayes to Zeal Head Cross, South Zeal**

- (i) the north-east side from a point 5 metres north-west of its junction with Tawton Lane to a point 5 metres south-west of that junction
- (ii) the north-east side from the boundary of Tor Cottage and Hillside in a south-easterly direction to the boundary of Beacon Cottage and Beacon View
- (iii) the south-west side from the south-eastern building line of St Mary's Church in a north-westerly direction for a distance of 12.5 metres
- (iv) the south-west side from the north-western property boundary of Moorside for a distance of 5 metres in a north-westerly direction
- (v) the south-west side from the north-western property boundary of Yellands for a distance of 10 metres in a south-easterly direction
- (vi) the south-west side from the south-eastern building line of Little Cottage for a distance of 15 metres in a north-westerly direction
- (vii) the south-west side from the extended south-eastern building line of Shelly Bakery in a south-easterly direction to the extended boundary of Shelly Down View and Shelly Close

**Road Over Moorlands Bridge, South Zeal**

both sides from the boundary of Nos. 1/2 The Croft in an easterly direction to a point 7 metres east of its junction with The Croft

**Tawton Lane, South Zeal**

- (i) the north-west side from its junction with Road from Shilhayes to Zeal Head Cross in a north-easterly direction for a distance of 7 metres
- (ii) the north-west side from a point 2 metres north-east of the boundary of Narramore Cottage and South Tawton Primary School in a south-westerly direction for a distance of 5 metres
- (iii) the south-east side from its junction with Road from Shilhayes to Zeal Head Cross in a north-easterly direction for a distance of 9 metres

**The Croft, South Zeal**

both sides from its junction with Road Over Moorlands Bridge northwards to a point 6 metres south of the southern building line of No.2 The Croft

**Schedule 4.108 Limited Waiting 8am-6pm 30 Minutes No Return Within 1 Hour**

**Road from Shilhayes to Zeal Head Cross, South Zeal**

the north-east side from a point 5 metres south-east from its junction with Tawton Lane in a south-easterly direction for a distance of 10 metres

**Schedule 9.001 School Entrance Clearway No Stopping At Any Time**

**Tawton Lane, South Zeal**

the north-west side from a point 2 metres north-east of the boundary of Narramore Cottage and South Tawton Primary School in a north-easterly direction for a distance of 43 metres
